Minutes of Meeting held on Wednesday 29th January 2013

2/ Approval of Previous Minutes

The Minutes of the PVOA Meeting held on 13th December 2012 were approved

3/ Update of Actions from Sarah Wilson, Charles White Factors

The fire at 4/14 Powderhall Rigg

Sarah reported that the external repairs were completed and that it was likely that the property would be put up for sale as soon as the interior repairs and redecoration were completed. Redecoration of the stair at 4 The Rigg will be undertaken under the insurance cover once the property has been emptied of its contents.

Compilation of an Overflow / Gas Outlet Pipes Plan for Road/Brae and Rigg Charles White is preparing a comprehensive site plan showing all pipe / electricity outlets. This is ongoing and is being undertaken block by block.

Children's Play Area Entrance

Work has been authorised. However, to date it has been too cold and wet to proceed and the contractor has advised Sarah that completion will be February or March.

Lift Contracts

The revised lift maintenance contracts with Schindler will be implemented as from March.

Recommendation of Common Areas Re-decoration

In step with the Powderhall Village Deeds & Conditions, redecoration tenders have been received from TW Scott, Hugh Muirheads and Brian Scott for Powderhall Road, Brae and Rigg. There are currently three quote options, but bearing in mind the differences between the decoration in the Road, Brae and the two blocks of the Rigg, 2-6 and 7-11, it was decided to look for a less costly option.

The Committee has therefore asked Sarah to get estimates for stripping, re-lining and painting the ground floors of 7-11 Rigg and Brae, and for washing the upper areas.

Re-issue of Parking Permits

Current Powderhall Vilage houshold parking permits expire at the end of February 2013 and therefore Charles White will shortly be issuing all owners with new Permits.

Charles White (Factors)

For the information of all Powderhall Village Owners/Residents, Charles White will shortly be moving its offices from Morningside to Haymarket. Powderhall Village owners will be kept informed as to where and when.

4/ Residents Parking and Powderhall Road Adoption

The Council has at long last met with Taylor Wimpey and it has been agreed between them and Councillor Hinds that Powderhall Village owners will be offered two options:

- 1. Partial Adoption of the roads and pavements excluding the parking bays.
- 2. A Parking Permit discount arrangement which would involve full adoption of the roads, pavement and parking bays with the implementation of Council parking controls..

The next meeting of the Transport and Environment Committee is on 19th March 2012 after which it is hoped that the matter wll be progressed. The Committee of the Powderhall Village Owners Association unanimously agreed that the first was the only acceptable Option. If any owner disagrees with this decision, they should contact the PVOA Secretary.

5/ Upgrading of Web Site

It has been agreed that the PVOA Web Site be re-designed. Both Dougie and Gordon have set up test systems and will meet in the next week or two to progress things. It was suggested that the Greyhound motif might be re-styled with colour.
